Contributions to People for Ben are limited to \$4,800 per individual (\$9,600 per couple) and federal multi-candidate PACs may contribute \$5,000 per election (\$10,000 maximum). A husband and wife may contribute a maximum of \$9,600 by one check drawn from a joint account and signed by both individuals. PEOPLE FOR BEN does not accept contributions from registered federal lobbyists.

Contributions to People for Ben are subject to the prohibitions and limitations of the Federal Election Campaign Act. Contributions from corporations, national banks, federal contractors, and foreign nationals who are not admitted for permanent residence in the United States are prohibited. All contributions must be made from personal funds and may not be reimbursed or paid by any other person. PAC checks will be accepted. Federal law requires us to use our best efforts to collect and report the name, mailing address, occupation, and name of employer for individuals whose contributions exceed \$200 in an election cycle.
